Candidates who possess educational qualification as mentioned and passed (date of result of final examination) within two years from the closing date of application, and medically fit as per the provisions of the Apprentice Act, 1961 are eligible to apply for apprenticeship in POWERGRID.

Candidates are not eligible to apply for the apprenticeship in any case -

- 1. Awaiting the results of their final examination.
- 2. Not completed the 18 years of age
- 3. Undergone apprenticeship training in any organisation for any duration.
- 4. Job experience of more than 1 year

#### General:

If any candidates found not eligible/ providing false information/ documents are not in order, shall be disqualified at any stage during the engagement process or during the period of engagement.

Incomplete applications or applications submitted without proper documents will be summarily rejected without any intimation. The date of result declaration and percentage of marks in the final examination of qualification degree (not semester examination) should be clearly mentioned in the final/consolidated mark sheet. If the percentage marks are not mentioned in the final mark sheet, then candidates should upload the Percentage Conversion Letter issued by their college/university.

On successful completion of document verification, submission of medical certificate in prescribed format and the execution of Apprenticeship contract agreement, letter of engagement shall be issued to the candidates. NO TA/DA shall be paid for verification of documents.
