- 4. Candidates have to submit the reserved community certificate in the format mentioned in ANNEXURE I.

Eligibility criteria for EWS Candidates:

->Persons should not be covered under the scheme of reservation for SCs, STs and OBCs.

->Family gross annual income from all sources i.e. salary, agriculture, business, profession, etc. should be below Rs. 8 lac (Rupees eight lac only). Income shall also include income for the financial year prior to the year of application.

- ->Persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income.
- a) 5 acres of agricultural land and above
- b) Residential at of 1000 sq ft. and above
- c) Residential plot of 100 sq. yards and above in notified municipalities
- d) Residential, plot of 200 sq. yards and above in areas other than the notified municipalities.

5. Terms and conditions of the appointment:

- The appointment of Sr. Resident Doctor is purely on contract basis for a period of one year. The appointment does not confer any right for regularization or appointment in Railways
- ii. Duties and responsibilities of the Senior Resident Doctors will be as fixed by the Railway Administration from time to time. They will be required to perform the assigned duties as may be needed in the legitimate interest of Railway administration including National Programme or during Railway accidents, in addition to their to work in their specialty. The Senior Resident Doctors will be required to be on call duty not exceeding 12 hours/day and no private practice shall be permitted.
- iii. The Senior Resident Doctors will be eligible for weekly rest/off and leaves as per the extant instructions in force during their residency period will be clearly furnished in the offer of appointment.
- v. Residential unfurnished accommodation would be provided to Senior Resident Doctors subject to availability. If railway accommodation is provided after meeting the requirement of serving Railway Officers, an amount equivalent to applicable HRA payable to the directly recruited GROUP 'A' Officers and license fee of the Railway accommodation will be deducted from the monthly remuneration.
- vi. The contract can be terminated by the Railway Administration at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and conditions laid down in Railway Board's letter No:2000/H-1/12/27/Pt I dated-06:10.2000.
- vii.In the event of regular selection through UPSC, the service rendered on this Railway on contractual basis will not be counted for regularization or absorption
