**TENURE :**

The initial engagement will be for a period of 2(Two) years. Further, extension of engagement, as per Company's policy, may be considered based on performance of the Visiting Doctors / Clinical Psychologist and also requirement of the Division. Further, the remuneration per visit shall be revised by 10% upon extension of engagement.

- ✓ The Visiting Doctors / Clinical Psychologist will abide by the Company's Rules & Regulations governing their engagement.

- ✓ The Visiting Doctors / Clinical Psychologist will be required to visit the Company Hospital on suitable days as per the requirements of the Organisation for providing treatment to employees and their dependent family members. In the event of emergency, they will be called as and when required.
