**ADVERTISEMENT FOR RECRUITMENT TO THE POST OF JUNIOR RESIDENT
(NON ACADEMIC) FOR 06 MONTHS (CONTRACTUAL) AT AIIMS, BIBINAGAR**

1. Consequence upon the Govt. of India Ministry of Health & Family Welfare letter No A-11013/2/2019-PMSSY-IV-Part(1) (EO.8082044) dated 19th September 2021. All India Institute of Medical Sciences, Bibinagar invites applications (through Email) between 08th July 2022 to 30th July 2022 to the post of **Junior Resident (Non Academic)** under the Govt. of India Residency Scheme for 06 (Six) months at AIIMS, Bibinagar. Day of interview will be held 1st August 2022, 09:00 A.M (Tentative) at Administrative Block, 1st Floor, AIIMS Bibinagar. The candidate shall intimate to this Email ID **deanexamsoffice.aiimsbibinagar@gmail.com**, by 30th July 2022 before 05:00 p.m. who are appearing interview on 1st August 2022. The application form will be available at AIIMS, Bibinagar official website.

* As per guidelines EWS posts are not carried forward/or Considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for post subjected to condition that they will be considered for the post as an URs Candidate only if EWS category seat is otherwise not filled

4. **EDUCATION QUALIFICATION:-**

➤ The candidates should have passed MBBS (including completion of Internship) or equivalent degree recognized by MCI.

➤ MCI/State Registration is mandatory before joining, if selected.

5. **APPLICATION PROCESS:**

6. **APPLICATION FEES:-**

- The candidate must produce the receipt of requisite application fee at the time of interview without fail.

7. **DOCUMENTS REQUIRED:** Attested photocopies of UG Degree, Certificates, Mark sheets, Age proof, Caste certificates.8. **UPPER AGE LIMIT:-**

- For eligibility to apply for the above said post, upper age limit as on last date of application will be **37 years**.
- Age relaxation of 3 years for OBC candidates and 5 years for SC/ST candidates.
- In case of PWBD candidates, age relaxation is upto maximum period of 10years for General Category, 13 years for OBC category and 15years for SC/ST category candidates.

9. **RESERVATION:**

- The reservation for EWS/OBC/SC/ST candidates is as per Central Govt. rules and 4 % for PWD candidates (on horizontal basis).

- For OBC Candidate: Candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 01 year from the last date of application.

- For EWS, OBC, SC and ST - Certificate should be issued by Tehsildar or above rank authorities prescribed by Govt. of India in format of State/Central Government.

- **For Persons with Disability (PWD):**

- The candidate must possess a valid document certifying his/her physical disability is conforming to judgment of Supreme Court of India i.e.: "With the approval of the Ministry of Health & Family Welfare, Govt. of India vide letter no. 18018/2/2009-ME(P-1) dated 17.02.2009 it has been decided that while providing reservation in admission to medical course in the first instance candidates with disability of lower limbs between 50% to 70% shall be considered and in case candidates are not available of such candidates in that category then the candidates with disability of lower limbs between 40% to 50% will also be considered for admission as per decision in the Writ Petition (Civil) 184/2005- Dr. Kumar Sourav Vs. UOI & others in the Supreme Court of India".

- The disability certificate should be signed by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/ Institutions & countersigned by Medical Superintendent.
- The constitution of the Medical Board will be one consultant each from disciplines of Orthopaedics, Physical Medicine & Rehabilitation and Surgery.
- PWD candidates who apply will be considered against seats in category in which he/she has applied i.e. GEN/EWS/OBC/SC/ST. Last seat/s in the respective category will be offered to PWD candidates, in case PWD candidate is not able to make on his/her their own merit.
- Physical requirement & Categories of disabled eligible for these posts is as follows:

• **FOR EWS (ECONOMICALLY WEAKER SECTIONS):**

- 10% of Vacancies are reserved for the EWS as per the directions of Government of India instructions issued vide DoPT OM No. 36039/1/2019-Estt (Res) dated 19th January 2019.
- Persons who are not covered under the existing scheme of reservations to the Scheduled Castes, the Schedule Tribes and the socially and Educationally Backward Classes and whose family has gross annual income below Rs. 8.00 lakh are to be identified as EWSs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the Following assets shall be excluded from being identified as EWSs, irrespective of the family income:
 - a. 5 acres of Agricultural Land and above;
 - b. Residential flat of 1000 sq. ft. and above;
 - c. Residential plot of 100 sq. yards and above in notified municipalities;
 - d. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
- The income and assets of the families as mentioned in Para 2 would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs. The candidates shortlisted for document verification/ interview shall be required to bring the requisite certificate as specified by the Government of India at the time of appearing for the process of document verification/interview. The income and asset certificate issued by one of the authorities mentioned shall only be accepted as proof of candidate's claim as belonging to EWS.
- The instructions issued by the Government of India in this regard from time to time shall be adhered to.

- Date of issue of Certificate should not be earlier than 01 year from the last date of submission of Application Form for Junior Residency.

10. SELECTION PROCEDURE :-


- Selection will be done only on the basis of Merit.
- Waiting list as may be deemed fit will be maintained. Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates post will be offered to the candidates from the waiting list according to the merit.
- Written examination may be conducted when number of applicants are more than three times than the number of posts advertised. However, there will be no written test for the post against which less number of applications are received than the vacancies. Director, AIIMS, Bibinagar shall have the discretion to decide for which post, written examination to be conducted and for which post there will be no written examination and his decision will be final.
- The merit list (selected and waiting list) for all categories i.e UR/EWS/ OBC / SC / ST shall be prepared on the basis of combined marks of written test and personal interview or only Personal Interview.
- Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit panel. All applicants must provide latest mobile numbers and e-mail for timely communication.
- For qualification /Reservation / Selection Procedure/Emolument/date of Interview and other latest details, candidates are advised to visit AIIMS, Bibinagar website regularly.
- Selected Candidate will be expected to stay in Institute Campus if offered residential accommodation.

11. TERMS & CONDITIONS

- The appointment is purely on contract basis for a period of 06(six) months, with effect from the date of joining. If the contract is not extended further, if not the same will lapse automatically. The appointment can also be terminated at any time, by either side, by giving one month's notice or by paying one month's salary, without assigning any reason. The appointee shall be on the whole time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. He/ She is expected to conform to the rules of conduct and discipline as applicable to the Institute employees. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
- If an appointee wishes to apply somewhere else or resign within the first 03 (three) months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any Relieving Letter or Experience Certificate.
- If any candidate, who joins the post and leaves/resigns/gets terminated before the completion of the tenure, he/she may do so by giving one month's prior notice from either side as per the rules or by depositing pay and allowance in lieu thereof with the Institute for the period of which notice falls short of one month or so.

- The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
- The candidate should not have been convicted by any Court of Law.
- In case of any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.
- The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- Incomplete applications in any aspect will be summarily rejected.
- Leave entitlement of the appointee shall be governed as per Govt. of India's Residency Scheme.
