It is to submit that vide reference  $l^{\rm st}$  cited above, Government has accorded permission to recruit posts of vacant MLHPs for which Government approval is already available further in supersession of orders issued in reference  $2^{\rm nd}$  &  $3^{\rm rd}$  read above ,Government has approved selection procedure for filing up of Mid –level Health provider (MLHP) posts on Contract basis .

- 2. Further, the Commissioner of Health & Family Welfare, Telangana State, and Hyderabad has requested the Chairman & District Collector, District Health Society, Mancherial to take necessary measures to filling up the total (37) Rural (19) and Urban (18) Mid-Level Health Providers (MLHPs) posts on Contract basis, Guidelines for recruitment are appended to this letter.
- 3. It is to informed that as per Government of India guidelines BUMS, BHMS and BNYS candidates are not eligible to hold the post of MLHP. It is therefore, requested to terminate the existing MLHPs with the above qualification after serving mandatory notice as per rules.

# <u>The Guidelines & Instructions for recruitment of</u> Middle Level Health Providers(MLHPs)-On Contract basis

\*First Priority will be given to MBBS, Second Priority will be given to BAMS (AYUSH) and Third Priority will be given to B.Sc. Nursing (Community Health) candidates for filling up of posts.

It shall be noted that these positions are not transferable.

- 1. Applications shall be invited by District Selection Committee, Mancherial headed by the District Collector.
- 2. Selection shall be done for MLHP posts as per the following priority:
  - a) MLHP posts of Sub centers (HWCS) that are located in Municipal areas should be filled with MBBS / BAMS Doctors only with preference being given to MBBS Doctors.
  - b) MLHP posts of Sub centers (HWCS) that are locate in other than Municipal areas, the recruitment shall be done in the following order of priority.
  - Doctor (MBBS/BAMS) with preference being given to MBBS.
  - Staff Nurse with B.SC Nursing who have graduated from the academic year 2020 onwards (or) staff nurse with B.SC Nursing /GNM who Graduated before the academic year 2020 & who completed six months bridge programme in Community Health (CPCH).
- 3. The District wise Number of vacancies in Health and Wellness centers for recruitment located in Municipal area is appended as Annexure –A. The District wise Number of vacancies of for recruitment Health and Wellness centers located in Non Municipal areas is appended has Annexure –B.
- 4. In the Health and wellness centers located in Municipal areas, the positions will first be filled up with MBBS Doctors as per eligibility. After exhausting the MBBS Doctors, these vacancies will be filled with BAMS Doctors as per eligibility.
- 5. In the Health and wellness centers located in Non Municipal areas the positions will fires be filled up with MBBS Doctors as per eligibility After exhausting the MBBS Doctors, these vacancies will be filled with BAMS Doctors as per eligibility .if no Doctors are available, then these positions can be filled up by staff Nurses as per the eligibility.

# 6. <u>Age</u>

- The minimum age is 18 years and the maximum age is 44 years.
- The minimum and maximum age shall be reckoned as on 01.07.2021 with the following reservation allowed for reckoning the maximum age limit as per rules in force:

## 10) <u>Selection procedure</u>

- i) Selection will be done based on the combined percentage of marks obtained in all years of MBBS/BAMS/B.SC Nursing /GNM.
- ii) Rule of Reservation shall be followed as per previous recruitment Government orders from Time to Time .
  - Rule of Reservations in respect of Community, Disability, Ex-Service Men/Women shall be strictly observed as ordered by the Government of Telangana from time to time.
  - The Rule of Reservations to local candidates is applicable as per the Presidential order.
  - The roaster will be continued as per previous MLHP/CHO notification.
- iii) Presidential Order -2018 has be followed .As per presidential Order -2018, MBBS and BAMS doctors are Multi-zonal posts and staff Nurses are Zonal Posts.
- iv) Since Health and wellness Centers located municipal areas are to be filled up by only MBBS / BAMS doctors, they will be permitted to opt further urban or rural Health and wellness centers or both.
- v) Notifications shall be issued by DSC.

### 10) Selection will be done on MeritBasis: -

Selection will be done based on the following criteria:

- I) Merit Lists shall be prepared separately for each of the categories.
- a) The selection to the positions shall be done by exhausting all the eligible candidates from the Merit List of Medical Officers- MBBS.
- b) After exhausting the selection from the Merit List of Medical Officer-MBBS, the vacancies shall be filled by the eligible candidates from the Merit List of Medical Officers BAMS -AYUSH.
- c) After exhausting the selection from the Merit List of Medical Officer BAMS-AYUSH, the remaining vacancies shall be filled by the eligible candidates from the Merit List of B.Sc. Nursing (Community Health)/GNM (CPHC).
- II) Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for the age. Weight-age for age will be reckoned from 18 years of age of the candidate. 0.5 mark will be awarded for one completed year of age with a maximum of 10 marks. The age will be reckoned as on 01-07-2021.
- III) Merit Lists will be prepared based on the marks obtained with above criteria and displayed on the Mancherial district official website for transparency and also for calling up the Objections on Provisional Merit List.
- iV) Final Merit List will be prepared after rectification of the Objections on Provisional Merit List by the candidates.
- v) Selection List will be prepared from the Final Merit List duly following the Rule of Reservation and Presidential orders.
- VI) The Selected Candidates shall maintain the headquarters.
- VII) It shall be noted that, these positions are not transferable.
