2.AGE:

The minimum age is 18 years and maximum age is 44 years as on 01.07.2023 with the following relaxations allowed for reckoning the maximum age limit as per existing rules:-

- i) For SCs, STs & BCs 5 (Five) years
- ii) For ex-service women 3 (three) years in addition to the length of service in armed forces.
- iii) Disabled persons 10 (ten) years

3. LOCAL Status

The rule of reservation of local candidates is applicable as per the presidential order as defined in Para-7 of G.O.Ms.No.124, General Administration (SPF-MC) Department, dated : 30.08.2018.

The details of Zones and the Districts covered in the Zones, is enclosed in the Annexure to these Guidelines.

4. Selection Criteria:

- a) Selection will be based on the combined % of marks obtained in all years of Qualifying Examination.
- b) Merit list will be prepared based on the marks obtained in the qualifying examination and on Zonal basis.
- c) Selection will be on Zonal basis.

5. General Guidelines to the Candidates:

- 1) Only Female candidates are eligible for this post.
- 2) The particulars furnished by the applicant in the online Application Form will be taken as final based on particulars uploaded only. Therefore, candidates are to be very careful while uploading in online Application Form.
- 3) Incomplete/incorrect application form will be summarily rejected. The information, if any furnished by the candidate subsequently, in any other format of application will not be entertained. Applicants should be careful in filling-up the application form and submission. If any lapse is detected during the scrutiny, the candidature will be rejected even though she comes through the final stage of recruitment process or even at a later stage.
- 4) The appointment for above posts on contract basis is purely on temporary basis and is liable to be terminated at any time without any notice or assigning any reason thereof,
- 5) Contract period will be for one year from the date of commencement of agreement/ or from the date of reporting.
- 6) This contract appointment does not confer any right for regular appointment.
- 7) They are only eligible for Casual Leaves as per rules per year and 120 days of Maternity leave for women without any pay and they are not eligible for any kind of Leave like Earned Leave, Half Pay Leave or Commuted Leave and in case of unauthorized absence for more than one month, their services will be terminated without any notice.
- 8) The temporary services for the above posts on contract basis do not qualify for any pensionery benefits.
- 9) The contract appointment to the post in the institution to which posted, shall be to the entire satisfaction of the superiors and incase of any default, candidate will be liable for termination without any notice.
- 10) The contract appointed candidate has to maintain absolute integrity and devotion to his/her duties.
- 11)If the contract appointed candidate is willing to resign, she should submit one month prior notice in advance, to the undersigned.
- 12) That the candidate will not be transferable from the place of posting to any other place during the period of contract. However, keeping in view of Medical emergency, Employer has the right to shift his/her services, wherever is required, for administrative convenience.
- 13) That the selected candidate has to execute an agreement bond in the format on a non judicial stamp paper worth Rs.110/- agreeing to the above terms and conditions, from the date of reporting for duty concerned.

6. Instructions to candidates for filling up of online application form:

- 1. Candidates are instructed to visit webpage i.e. https://forms.gle/oXbXzU1MtYi1bbv79 and fill the online application for the post of Radiographer (Only Female Candidates are eligible).
- 2. Online Application Form will be available from 28.03.2023 to 30.03.2023 till 5.00 PM.
- 3. Candidates shall give their preferences of postings in the Zone, to which they belong, while filling up of application.
- 4. After submission of online application, a message will be received in the email id of the candidates.

- 5. Candidates are directed to <u>download the online application form</u>. The <u>same shall be signed and submit</u> the same alongwith a set of following Xerox certificates at O/o the Commissioner of Health & Family Welfare & Mission Director, National Health Mission, 4TH Floor, DME Building, DM&HS Campus, Koti, Hyderabad on 31.03.2023 from 10.30 AM to 5.00 PM. They shall also bring the following Original Certificates for verification:
 - i. SSC or Equivalent examination.
 - ii. Intermediate (or) 10 + 2 examination.
 - iii. Latest Caste Certificate issued by the Tahsildar/MRO concerned.
 - iv. Relevant certificates in respect of candidate claiming PH, Ex-Serviceman and EWS and other quota.
 - v. Bonafied certificates for the study from 1st to 7th class and in case of private study, Residence certificate from the Tahsildar/MRO concerned.
 - vi. Qualifying Exam Marks memos of concerned Board or University (Consolidated/Year wise).
 - vii. Convocation/Provisional Certificate of Qualifying Exam from the board/university concerned.
 - viii. Registration Certificate from the T.S. Para Medical board.
 - ix. One photograph duly pasted and signed across on the application form.

Note:

If the candidate failed to attend the original certificate verification process on the mentioned date(31.03.2023), the candidature will be disqualified.

7. General Information:

- 1) The Commissioner of Health & Family Welfare and Mission Director, National Health Mission, Hyderabad reserves the right to change/modify/cancel the selection process at any time during the process. The decision of the CH&FW and MD, NHM will be final and binding.
- 2) The Mode of Appointment is on Contract basis for a period of one year or till the actual need ceases whichever is earlier.
- 3) No TA/DA will be paid to the candidates for attending the Verification process.
- 4) Appointees will work under the overall administrative control of CH&FW&MD.,NHM.
- 5) Candidates selected shall be appointed on Contract basis in the Districts.
- 6) The Panel of Candidates will be utilized for future vacancies, until a period of one Year from the date of Notification.
- 7) Their performance will be evaluated from time to time and also the same will be considered for Extension/Termination of their service, in case of future requirements.
