#### **Essential Qualifications:**

Matriculation or equivalent pass

#### Age:

Between 18 and 25 years. The maximum age limit for OBC (Non Creamy Layer) PwBD – B & LV candidates shall be 38 years on the closing date.

#### Job Responsibilities:

Physical maintenance of records, general cleanliness & upkeep, carrying of files & other papers, photocopying, assisting in routine office work like diary & despatch etc. including on computer, delivery of dak, bank and Post office work, and any other work assigned by the superior authority.

#### **GENERAL INSTRUCTIONS / INFORMATION**

1. The pay & allowances are admissible as per the Government of India order applicable to the Society. Other benefits include New Pension Scheme, Medical reimbursement, and LTC, as per the Society's rules.

2. The upper age limit is relaxable for OBC (NCL)/Ex-Servicemen (OBC-NCL) candidates belonging to Persons with Benchmark Disabilities (PwBD) as per Govt. of India orders issued from time to time. The age limit will be applicable as of the closing date. Therefore, Candidates born on or before 18.06.1985 [subject to the release of the advertisement in the Employment News dated 20-26 May 2023 edition] are not eligible for Direct Recruitment and hence need not apply. For others, age relaxation to be given to Government Servants would be governed as per DoPT's instructions issued from time to time.



3. A candidate who claims to belong to Persons with Benchmark Disabilities (PwBD) belongs to OBC (Non-creamy layer) has to submit two separate certificates in the prescribed form issued by the Competent Authority specified by the Central Government.

4. Government strives to have a workforce that reflects gender balance. Hence, women candidates fulfilling the eligibility criteria are encouraged to apply.

5. The interested candidates must submit the application form in the prescribed format, testimonials along with a Demand Draft for Rs.250/- towards application fee. The application fee is not-refundable under any circumstances. D.D./bank draft shall favour "C-MET", Payable at Hyderabad. 6. Those employed in Govt. Deptt/PSUs/Autonomous Bodies should send their application through the proper channel within 21 days from the closing date; otherwise, their application will not be processed/screened for written examination. Therefore, the candidate to ensure that his application is forwarded within the stipulated date through the proper channel.

7. The selection mode will be based on written test only, and there will be no interview. The written examination test will be held at HYDERABAD (TELANGANA STATE). The date, venue and syllabus for the written examination will be notified on our website only.

8. The Centre reserves the right to increase or decrease the number of post(s), not to make recruitment to any post(s), shortlist candidates for written test, and accept or reject any application at any stage without assigning any reason.

9. The number of vacancies is subject to change, and the Centre reserves the right in this matter.

10. No interim enquiries/correspondence/communication of any sort will be entertained on the matter and or after the selection procedures. The information shall be provided to the shortlisted candidates for the written test by email. However, the offer of appointment to the selected candidate will be sent through Registered/Speed-Post followed by email.

11. Canvassing in any form and/or bringing any influence, political or otherwise, will be treated as a disqualification for the post.

12. Application incomplete in any respect and not accompanied by relevant certificate/documents/photograph/prescribed application fee/incomplete application/ application, not in the prescribed format, will be summarily rejected. All documents to be attached with the application format shall be Self-attested viz certificates, marks sheets, testimonials, etc.

13. The original documents will be verified at the time of written test; if the candidate fails to produce the original documents at verification, they will not be allowed to attend the written test. Detailed information regarding this will be indicated in your call letter.



14. Please use separate sheet(s) wherever required.

15. Applications that do not meet the criteria given in this advertisement and are found incomplete are liable to be summarily rejected.

16. Application (a) not in the prescribed format, (b) incomplete application, (c) without self-attested certificates, (d) photograph and (4) prescribed fee shall be liable to be rejected.

17. Candidates should not furnish any particulars which are false, fabricated or tampered with educational qualifications or suppress any material/information while applying. The appointment of the selected candidate shall be subject to verification of educational qualification/experience.

(i) The prescribed Essential Qualifications indicated are the bare minimum, and mere possession of same will not entitle the candidates to be shortlisted for a written test. The Laboratory has the right to shortlist a limited number of candidates amongst the eligible candidates as per the essential/desirable/qualification for the written test.

(ii) Where the number of applications received in response to an advertisement is large, it may not be convenient or possible for the Laboratory to be called for a written test/skill test of all the candidates. 19. The candidate shall bear all expenses for appearing in the written test, and no TA / DA will be paid for attending the written test.

20. Please note that all future correspondence regarding the date of written examination, results etc., shall be uploaded on the society website and sent to the email ID provided by the candidates. Candidates should ensure that the email ID provided is correct/legible. The candidates should check their email (including spam) & society website regularly. 21. If any information is delayed due to technical reasons, the Society will not be responsible.

22. The Society shall verify the antecedents of the selected candidate and the documents submitted by him/her at the time of appointment or during the tenure of the service. In case it is detected that the documents submitted by the candidate are false or that the candidate has suppressed relevant information. Their services shall be liable to be terminated without prejudice to any other action initiated by the Society.



23. In case of any inadvertent mistake in the selection process, which may be detected at any stage, even after the offer of appointment/ appointment letter, the Society reserves the right to modify/cancel/withdraw any communication made to the candidate.

24. The candidate's admission to the written test is strictly provisional. The mere fact that the call letter has been issued to the candidate does not imply that C-MET has finally cleared his candidature. Detailed instructions regarding the written test will be sent to shortlisted candidates by email only, and it will also appear on the website of C-MET.

25. At present, the place of posting is Hyderabad, but liable to be transferred to any of the C-MET labs.
