

Attention is invited to the subject and reference above cited.

It is to inform that, as per the Standard Operating Procedure (SOP) of the Child Helpline (CHL), the human resources under Child Helpline (CHL) will be engaged for the welfare of Children in Need of Care and Protection (CNCP) and Children in Conflict with Law (CCL), who will play a vital role in the prompt and effective delivery of services as well as ensuring safety and protection of children in difficult circumstances. The staff shall be engaged on *outsource basis* and shall ordinarily be up to the 15th Finance Commission cycle i.e., up to 2025-26 subject to annual performance appraisal.

It is further to inform that, as per the Standard Operating Procedure (SOP) of Child Helpline (CHL), certain instructions are issued and the details of the same are as follows;

1. The Child Helpline (CHL) staff to be recruited on Outsourcing basis:

As per the Standard Operating Procedure (SOP), One Child Helpline (CHL) is approved to each district and the positions under Child Helpline (CHL) are to be recruited on Outsourcing basis. Further, the CHLs are to be attached to DCPU under Bala Raksha Bhavans.

2. The age criteria is considered on par with the Mission Vatsalya (CPS) staff with 21-35 years and age relaxation of 5 years to the SC/ST/BC applicants.
3. Staff pattern, the salaries of the Child Helpline (CHL) Staff, qualification and experience criteria and confirmation of no. of positions (where the range is given):
