Sub: Deputation of an IRTS Officer for the post of Executive Director (Coal Movement) in SCCL - Reg.

M/s. SCCL is a Govt. Company owned by Govt. of Telangana and Govt. of India with an equity of 51 and 49 percent respectively. The company set with an annual targeted production of 72 Million Tonnes and supplies to power sector and other consumers across the country. In view of the extensive rail linkage facilities required to be arranged for SCCL for movement of coal, the Coal Movement department of the company has been headed by a senior IRTS officer.

We are happy that Ministry of Railways has been deputing senior IRTS Officers to the Singareni Collieries Company Limited since many years to head the Coal Movement Department of SCCL in Hyderabad. The present incumbent Dr. J. Allwyn, IRTS will be repatriated to his parent department, Indian Railways, with effect from 30.06.2024 (afternoon) on completion of 5 years and 6 months tenure with SCCL and hence there is a need to post a senior IRTS Officer in his place.

The post of Executive Director (Coal Movement) is a senior level position in the Company. Apart from possessing high degree of integrity the incumbent should maintain close liaison with Railways, Central and State Government Officials.

It is requested to forward a panel of 5 IRTS Officers of JAG/Selection Grade with the experience of at least two years in commercial and operating branches in South Central Railway Division with adequate experience in matters of General Administration, dealing with Government of India and Government of Telangana, public and private organizations.

Further, it is requested to forward the Bio-data and ACRs for the last 5 years of the officers at the earliest for enabling us to select a suitable successor to the present incumbent.
